The company is currently exploring external investment opportunities to increase its capacity to 2.5 times existing levels. If successful, the Company would undertake an 18-month investment plan of $\pounds 20-\pounds 25m$ in new capital expenditures and facility expansion which would also increase employment by a further 25%.

The company also operates a highly successful graduate and modern apprentice scheme, with 9 local employees undertaking training and further education to develop their future career in the semiconductor industry.
